

# Ault Alliance's Subsidiary, Sentinum, Completes Initial Bitcoin Mining Installation at Montana Location

LAS VEGAS--(BUSINESS WIRE)-- [Ault Alliance, Inc.](#) (NYSE American: AULT), a diversified holding company (“**Ault Alliance**,” or the “**Company**”), announced today that its wholly owned subsidiary, [Sentinum, Inc.](#) (“**Sentinum**”) has received 1,000 Bitcoin miners from its Michigan Facility at one of its two Montana Bitcoin mining sites. Those miners are currently being installed and the Company anticipates that a majority of them will be actively mining Bitcoin this week. Sentinum believes that approximately 2,250 Bitcoin miners will be installed and mining over the next three months. The Company has previously announced plans to move its Bitcoin mining operations out of its Michigan Facility, thereby enabling that site to support hosting services for artificial intelligence infrastructure and enterprise customers.

William B. Horne, Chief Executive Officer of Ault Alliance, remarked, “The installation of the first 1,000 units marks a significant step in the right direction for Sentinum. We are continuing with our stated plan and focusing on moving all Bitcoin mining operations out of the Michigan Facility, and into our Montana locations as well as potentially exploring other hosting agreements with third parties. We expect the two Montana locations to house approximately 6,500 machines over the coming months.”
